Welcome Address

Welcome to the Global Conference on Economic Geography 2018!

It is an honour for us to host the fifth Global Conference on Economic Geography in Cologne after the conferences in Singapore in 2000, Beijing in 2007, Seoul in 2011, and Oxford in 2015.

We are delighted at the number of colleagues coming to Cologne. We expect about 700 presentations from over 800 participants from more than 50 countries.

The title "Dynamics in an Unequal World" is based on the premise that the current world is far from being 'flat' or the same everywhere. Worldwide, we see a mosaic of different and sometimes contradictory developments in which some regions and economies rise, while others stagnate or even fall. In addition, rising inequality within countries is challenging social coherence not only in the so-called Global South, but also in the Global North. Populist movements in the US and Europe are in many ways the result of an increasing number of people feeling marginalized by globalization.

The growth of specialized economic clusters and the increasing number of company headquarters in global cities are only two examples of dynamic agglomeration processes fostering global divergence. At the same time, various regions worldwide are largely being excluded from economic growth. In particular, many agglomerations in the Global South fail to sustainably benefit from globalization and structural change. What are the drivers of these uneven developments and what are the implications for wellbeing and social coherence? Who will be the winners and who the losers? These are challenging questions as globalization has continuously been integrating more and more regions into the global division of labour. Today, restrictive trade policies seem to be challenging internationalization but it is hardly conceivable that this might really call the globalization of companies, technologies, and goods into question. Economic geography, with its focus on uneven development, is well-positioned to map and explain these dynamics, explore the implications, and formulate new ways in which economies can be conceptualized and researched.

In order to achieve this, we have aimed for a broad mix of colleagues and contributions. We have particularly supported submissions from the Global South and from young scholars and we have also focused on gender issues. While we have successfully managed to attract younger scholars and more colleagues from the Global South than ever before, the latter is still a challenge. High travel costs are still an important obstacle to attracting colleagues from many parts of the Global South even though we have tried our best to keep the conference fees low and to provide support with financial grants. Hence, we would like to take the opportunity to thank the journals *Economic Geography* (Clark University/Taylor and Francis), *Environment and Planning A: Economy and Space* (SAGE), and the *Economic Geography Research Group of the Royal Geographical Society* (with the IBG). Together with these organizations and further backing, we have been able to support the winners of our travel grants. We would also like to thank the advisory board of over 50 international colleagues and, in particular, Henry Yeung and Dariusz Wojcik for their comprehensive support.

During the conference, we will run 10 to 13 parallel sessions. Each day will finish with a special thematic highlight. This includes the plenary sessions "*The Geographical Roots of Inequality and the Future of the Liberal International Order*" and "*Feeding the Global South. How do Local and Global Processes contribute to Food Justice?*" as well as "*Poverty and Inequality: Trends, Drivers, Policy Options*" and our World Café "*Dynamics of Unequal Developments in the Global South*".

To complement our programme, we invite you to explore the Cologne region, for example, during our afternoon and full-day excursions. There is still an opportunity to participate in some of these excursions. In addition to this, we hope to meet many participants at our social events such as the welcome reception and the conference dinner. There is also the Icebreaker Party which we are sure will be a great opportunity to relax and have fun. Overall, we aim to provide a familiar, welcoming, and fruitful atmosphere.

We would also like to thank De Gruyter, Edward Elgar Publishing, Franz Steiner Verlag, the Regional Studies Association, Oxford University Press, Smith School of

Enterprise and the Environment (University of Oxford), Social Sciences (MDPI), Springer Nature, and our local partners Geoverbund ABC/J as well as the Faculty of Management, Economics and Social Sciences and the Global South Studies Center (both University of Cologne) for their support. We also thank De Gruyter for making a conference-linked special issue of the *Zeitschrift für Wirtschaftsgeographie* possible. And, of course, let us thank you the participants who have organized state-of-the-art sessions and panels, handed in excellent abstracts, and honour us with your presence.

To make this conference happen, we draw on the work of many highly committed people. These include the organizing team of Susanne Weber, Alexander Follmann, Anna Thau, Johanna Fellbrich, Andreas Bolten, and Phyllis Bussler. Some of them have been working since 2015 to ensure the success of this conference. Furthermore, we are able to rely on more than 15 student assistants and over 30 volunteers for whose commitment we are particularly grateful.

If we look back to the GCEGs we have attended in the past, we have always felt that they were very special and stood out amongst the many conferences that take place.

We hope that we too can achieve this feeling for you with this conference.

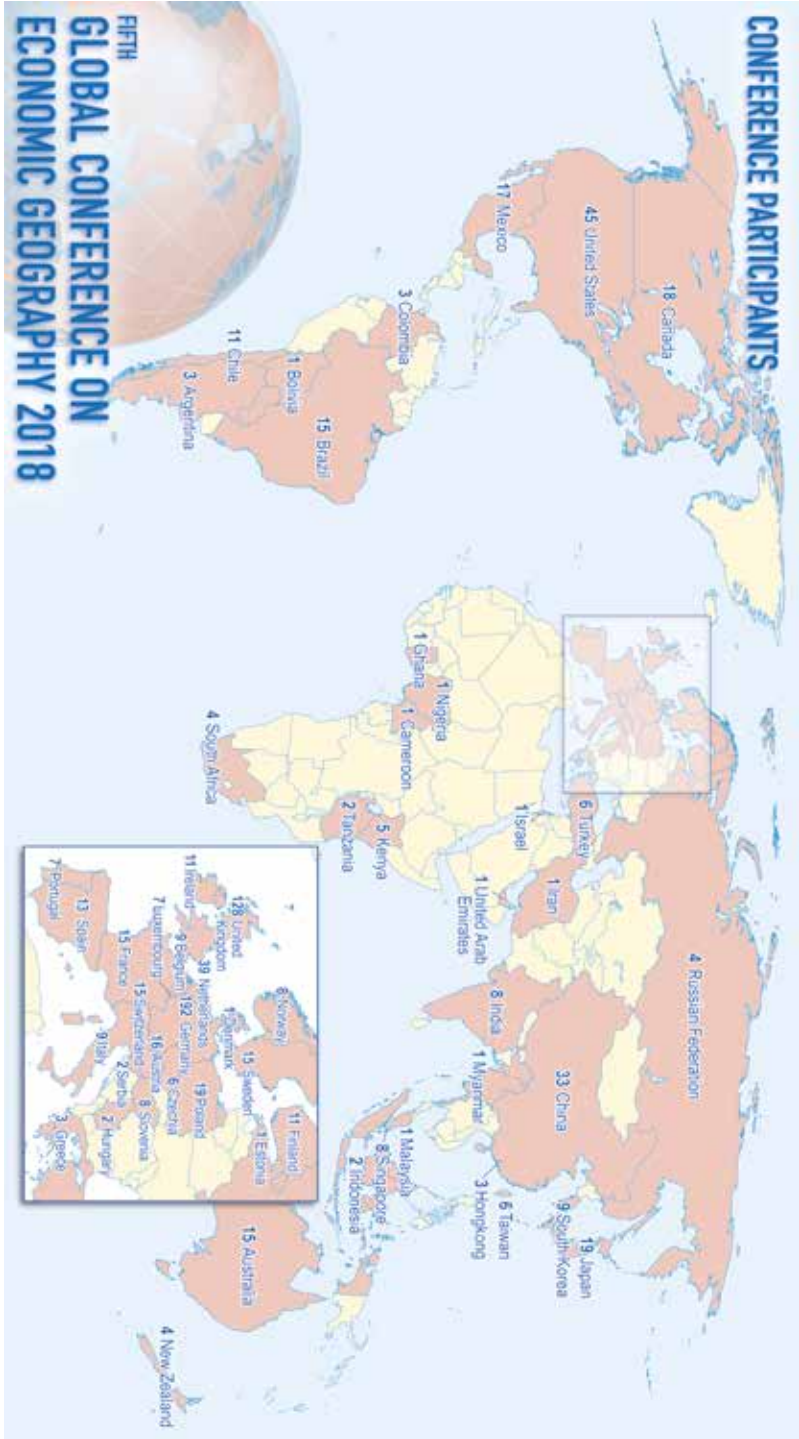

THE CONFERENCE VENUE

The University of Cologne is one of the oldest and, with about 50,000 students, one of the largest universities in Germany, offering a broad and diverse range of subjects and degrees including international double degree programmes. The origins of the University of Cologne date back to 1388, when the institution was founded as the fourth medieval university of the Holy Roman Empire. It ceased to exist with the French occupation in 1798.

The “new university” was opened in 1919 under Cologne’s then Mayor Konrad Adenauer (who later became the first Chancellor of the Federal Republic of Germany), emerging from already existing small academic institutions, such as the College of Commerce, the College of Social Administration, and the Academy of Medicine, which had their origins in the 1900s and merged as faculties in the newly founded institution.

Due to rising student numbers and a growth in departments and faculties, today’s Campus University was created in the south-west part of Cologne, a then undeveloped area. The main building, designed by the architect Adolf Abel, was inaugurated in 1934 and has continually extended since then. Today, the University of Cologne is not only an important institution in the regional educational landscape but is also a relevant cooperation partner for major research institutions in the region. On an international level, the University maintains more than 40 official university partnerships, alongside more than 300 additional academic partnerships on the faculty and department level. In 2012, the University of Cologne became one of eleven German Universities of Excellence. The Excellence Initiative is jointly carried out by the German Research Foundation (DFG) and the German Council of Science and Humanities (WR). In this context, the Global South Studies Center Cologne (GSSC) was created in 2014. The aim is not only to provide an interdisciplinary perspective on the Global South but also to bring together research and voices from all continents which is expressed in strategic academic partnerships with universities in Argentina, China, India, and South Africa.

Geography was present as an academic discipline in the newly founded university from the beginning, having emerged from the College of Commerce created in 1902. Today, the **Institute of Geography**, as part of the Faculty of Mathematics and Natural Sciences, comprises nine chairs of which four chairs are of Human Geography. Another chair of Economic Geography is in the **Department of Economic and Social Geography** at the Faculty of Management, Economics and Social Sciences.

HOW TO GET THERE

The conference venue is located in the heart of the University of Cologne campus and can easily be reached by public transport (see Map of Cologne: Conference Venue and City Centre and Map of Cologne: The University Campus).

From Cologne Central Station ("Köln Hauptbahnhof") :

Take the tram lines 16 or 18 to the stop *Neumarkt*, change to line 9 direction *Sülz* to the stop *Universität*. From there, it is a short walk (roughly 5 minutes) to the conference venue. The trams run roughly every 10 minutes.

Another option is to take a regional train (RE) from Cologne Central Station to *Köln Süd*.

From Köln Messe-Deutz:

Take tram line 9 direction *Sülz* to the stop *Universität*.

From Köln Süd:

Take the exit *Zülpicher Straße*. After the exit, along *Zülpicher Straße* to the intersection of *Zülpicher Straße* and *Universitätsstraße*. Turn right onto *Universitätsstraße* to the conference venue (roughly 10 minutes' walk).

Please note that standard electrical voltage in Germany is 230 V and standard frequency is 50 Hz. Electrical sockets in Germany are of type F and require an adapter plug of type C or F and/ or an electric converter for appliances. Please be aware that in some cases an additional voltage converter may be needed to meet German voltage and frequency standards as adaptors do not change the voltage or frequency of the supply.

Plenary Session I: Tuesday, July 24, 2018, **Building 3: Hauptgebäude, Aula**

The Geographical Roots of Inequality and the Future of the Liberal International Order

Panel Organizers: **Harald Bathelt (University of Toronto) and Michael Storper (LSE, UCLA, Sciences Po Paris)**

The past thirty years have generated a strong geographical spreading of capitalist market relations – especially to East Asia and the former Soviet Union. This has been accompanied by an unprecedented increase in global prosperity, measured by global per capita income, the massive expansion of the global middle class, and a precipitous decline in extreme poverty in many parts of the world. And yet, in many countries, there are growing populist movements that call into question unbridled globalization, liberal internationalism, and the rule of markets. Among the many varieties of such movements can be included the American election and the Brexit vote in 2016 and strong revanchist tendencies in many other countries worldwide from Russia to Turkey, Hungary and the Philippines.

There are undoubtedly many complex reasons for this new “age of anger”, ranging from economic to cultural. Principal among them are the growth in two kinds of inequality amidst general increases in prosperity: interpersonal inequalities in income and social status are growing in many countries, alongside geographical inequalities in prosperity, income, and opportunity. The globalized urban centers that were the drivers of economic growth and seemingly borderless networks have come under pressure and urban elites are claimed to be responsible for stagnation and decline in other regions.

Political entrepreneurs have assigned much of the reason for these inequalities to globalization and liberal internationalism and hence are prescribing remedies that involve retreat from global trade, global labor and capital mobility, and global political order and international obligations. A new populist turn in politics has mobilized masses of what could be referred to as disillusioned globalization losers that are ready to push for isolationist, anti-immigration, anti-globalization policies.

In this panel, we aim to discuss: the nature and reasons for the geography of inequalities; the nature and reasons for the strong regional or geographical expressions of populism/anti-globalism versus pro-globalism and openness; the possible futures of such movements and their geographical bases; and the consequences for re-thinking development policies, whether at the level of the architecture of globalization or at the scale of spatial-regional economic policies within countries.

Plenary Session II: Wednesday, July 25, 2018, **Building 3: Hauptgebäude, Aula**

Poverty and Inequality: Trends, Drivers, Policy Options

Panel Organizer: **Javier Revilla Diez (University of Cologne)**

Since the 1990s, global poverty has reduced considerably. However, poverty remains a substantial problem for many countries across the so-called Global South and in pockets of the Global North. According to the International Poverty Line, set at US\$1.90 per day for 2017, approximately 768.5 million people worldwide are considered extremely poor; if the poverty line is drawn at US\$2.50 per day, then almost half the world's population lives in poverty. Why is progress on poverty reduction so slow? This panel's discussions focus especially on growing internal inequalities within countries. Indeed, several emerging economies in Africa, Asia, and Latin America have achieved the status of middle-income countries. At the same time, income disparities remain high, or are even increasing, challenging social cohesion within and between countries. Against this background, this plenary session will focus on three core topics. First, it will discuss global trends in poverty and inequality, including methodological questions related to measurement and other challenges. Feeding the Global South. How do Local and Global Processes contribute to Food Justice?

Panel Organizer: **Boris Braun (University of Cologne)**

Between 2015 and 2016, the global number of chronically undernourished people increased from 777 million to 815 million. This reversed a decades-long downwards trend in the absolute number of people who were consuming insufficient calories for their daily energy requirements. Yet this alarming statistic reveals only one dimension of the world food problem. An additional 2 billion people eat enough calories for their daily energy needs, but don't receive the requisite vitamins and micronutrients for a healthy life. And 13 % of the world's adult population is overweight and obese, twice the prevalence in 1980. The conjuncture of these different dimensions of hunger and malnutrition represents the outcome of complex social, economic and environmental processes cutting across different geographical scales. This panel addresses this critical global problem. It asks how the place- and scale-sensitive foci of geographers can lead to new understandings of how and why food justice – defined as the right to a satiating, healthy, culturally appropriate and sustainable diet – still eludes so many on the planet. Moreover, the session aims to discuss practical strategies to overcome hunger and the undernourishment of millions of people in the Global South.

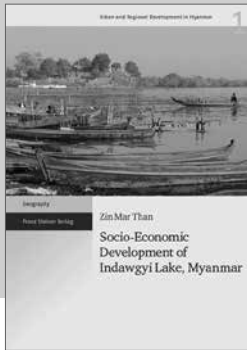

THE AUTHOR

Zin Mar Than received her PhD at the University of Cologne where she is currently a Research Associate at the Institute of Geography.

Indawgyi Lake in Kachin State, located in the northern part of Myanmar, is the largest inland freshwater lake in the country, with rich aquatic flora and fauna, high biodiversity and a (largely) intact ecosystem. Since 1999 the “Indawgyi Wetland Bird Sanctuary” has been declared a conservation area. Still, it is a peripheral region and lagging behind in its development. At present the three main economic activities are agriculture, fishing and gold mining. Zin Mar Than offers an in-depth analysis of the socio-economic situation of the area and identifies its future development potentials using the SWOT approach (Strengths, Weaknesses, Opportunities, Threats). In this context the author discusses concepts of endogenous development and sustainability. Special emphasis is placed on developing ecotourism as a fourth economic activity in the area and to meet the needs of long-term conservation.

COLOGNE CATHEDRAL

Cologne Cathedral is the landmark of the City of Cologne. While the beginnings of construction date back to medieval times, the cathedral was only finished in the 19th century. As a renowned monument of gothic architecture, it was declared part of the UNESCO World Heritage in 1996. Visits to the inner cathedral areas are possible every day between 6am and 9pm (except during mass). It is also possible to climb one of the towers (157m height). The cathedral is easily reachable by public transport as it is located directly next to the main station.

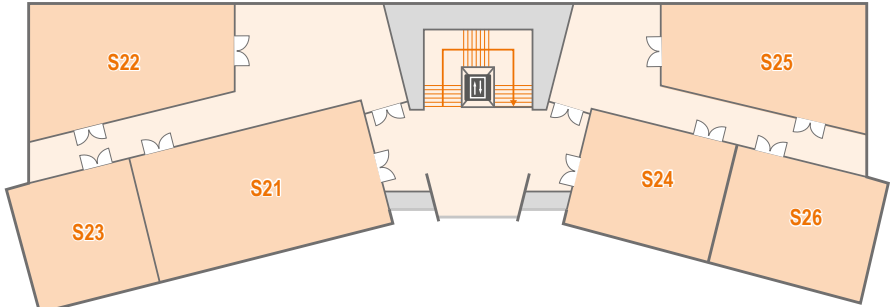

BUILDING 1: PHILOSOPHIKUM

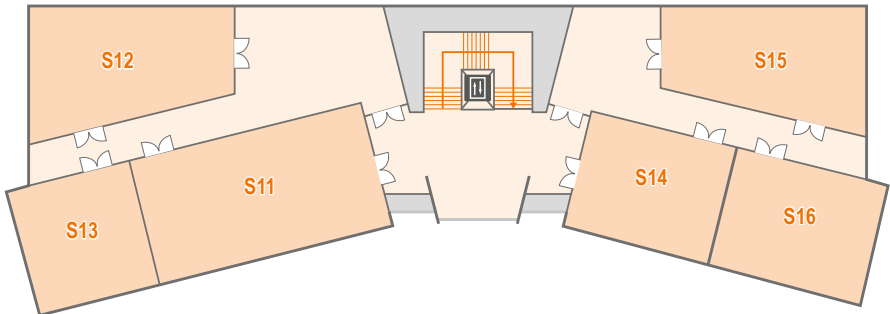

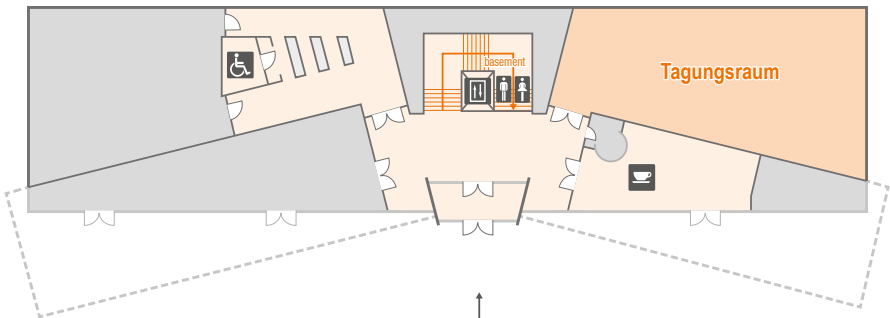

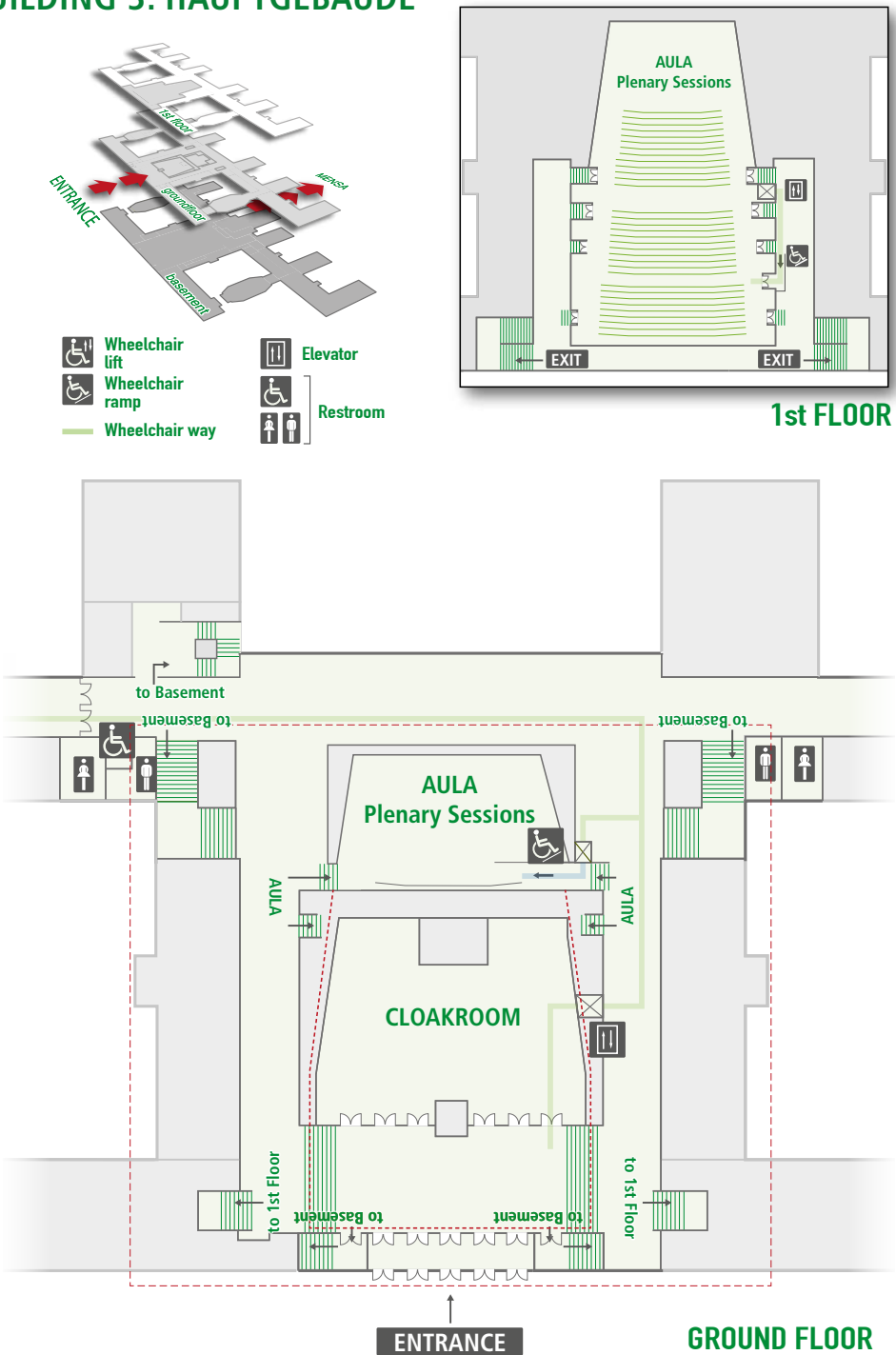

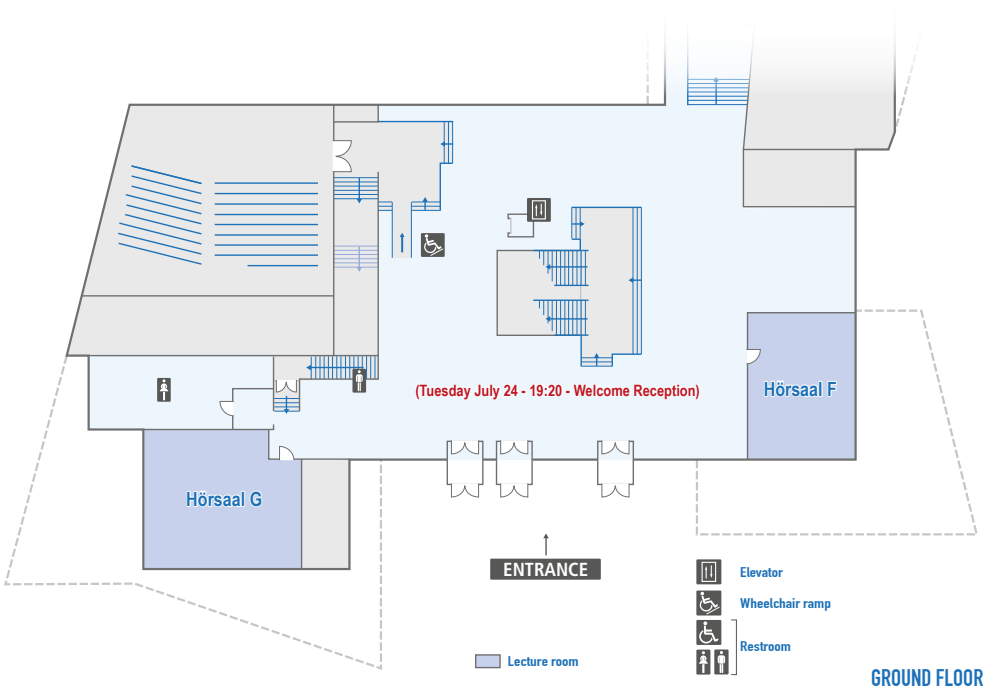

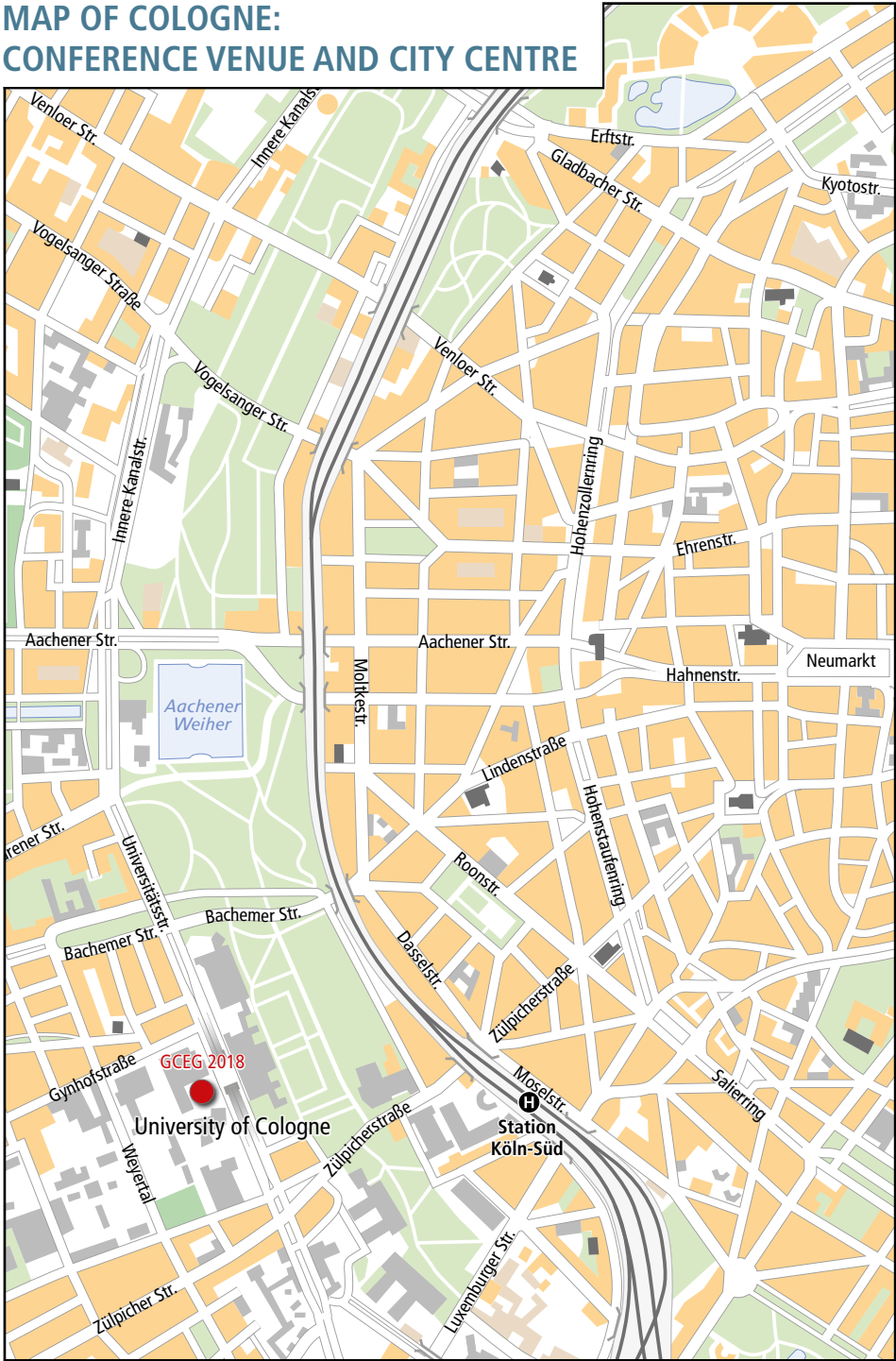

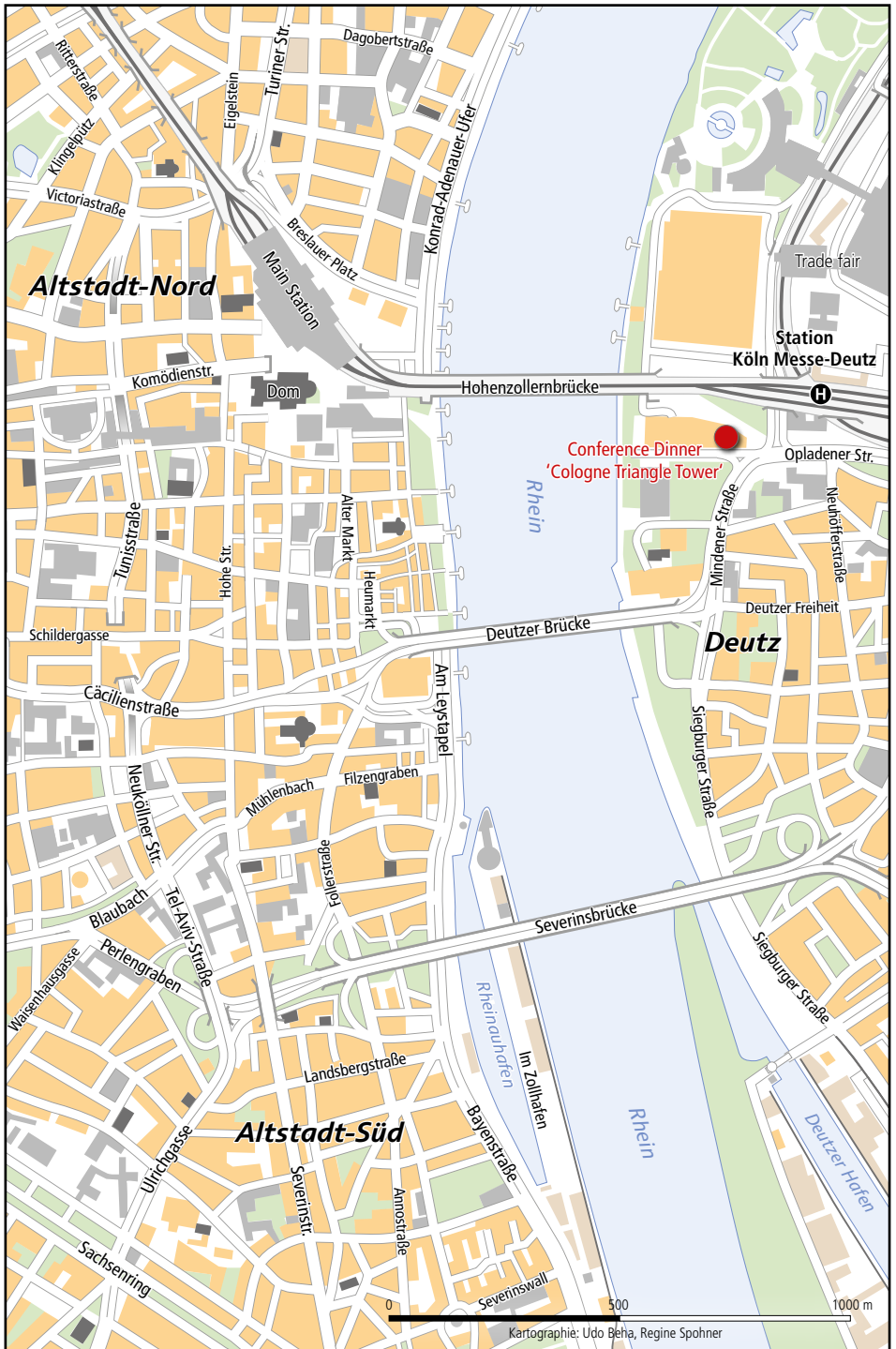
